#### Section 3 - Hazards Identification

\*\*\* Emergency Overview \*\*\*: Contains Silica, which may cause cancer. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. Harmful if swallowed. Causes eye irritation. Vapors irritating to eyes and respiratory tract. Combustible liquid and vapor.

Effects Of Overexposure - Eye Contact: Causes eye irritation.

#### **Section 4 - First Aid Measures**
